GUIDELINES and STYLE SHEET FOR AUTHORS

Although all papers presented at the WSFH annual meeting may be considered for publication, the *Proceedings* are peer reviewed, thus not all papers will be published. We look for articles that are ready for publication, that incorporate suggestions made by chairs and/or commentators, and that make a significant contribution to the field. While we do not expect articles as fully developed (or as lengthy!) as journal articles, we do expect that authors will have made the revisions necessary to transform a conference paper into an article, e.g., more formal tone, footnotes that direct the reader to important literature as relevant, etc.

The review process involves:

1. recommendations by a panel's chair and commentator about an article's suitability for publication;
2. the judgment of the editors;
3. in some cases, recommendations sought from an editorial board or other specialists in the author's field.

On this basis, the editors may accept an article without requiring substantial revision; accept an article conditional upon an author making suggested revisions; or reject an article.

**DUE DATE: 15 January 2012** is the due date for all materials, including copyright permission forms. No second call will be issued for errant or late submissions.

**FORMAT:** Please submit your articles via email as attachments in MSWord to the email addresses below. If you do not send the article via email, you may submit a hardcopy with a computer disk containing your article in MSWord. The hardcopy and disk must be postmarked by **15 January 2012**. Please mail these to Joelle Neulander (address below).

**COPYRIGHT FORMS:** This form is available on the WSFH website at <http://www.wsfh.org/Proceedings-Information.htm>. Please print out a copy, complete it, and return it via surface mail to the address below by **15 January 2012**. We will fill in the last section, "Journal Representative."

**COPY:** Please retain a copy of your contribution. Articles submitted for publication consideration will not be returned to authors.

**STYLE:** With the exception of some *Proceedings* idiosyncrasies, *The Chicago Manual of Style* [CMS], 15th edition or 16th edition, is the stylebook. **TYPESCRIPTS SHOULD CONFORM TO ITS RECOMMENDATIONS AS CLOSELY AS POSSIBLE.** References are given below to CMS and the appropriate section numbers. Articles not conforming to the proper style will be returned to authors and will not be considered for publication until submitted as requested.

**DATES:** Dates should all be European (diplomatic) style, e.g. 14 July 1789; 1790s (no apostrophe); hyphenate mid-1990s. No internal punctuation when using just month and year (e.g. the events of August 1914 were decisive). See CMS [15th ed.] 9:33-9:40 or [16th ed.] 9:30-9:37.

LANGUAGE : Articles are usually published in English; they may be published in French if they were presented in French at the meeting. Use English rather than French whenever possible (e.g., Old Regime instead of *ancien régime*, generality instead of *généralité*, nobility instead of *noblesse*). Translate ALL quotations into English unless the French version is vital for clarity, accuracy, or pungency. In that case, consider putting the English translation in the text and the original French in a footnote. If use of a French term is necessary, please put an English translation in parenthesis after the French. If a French or foreign language title appears in your text whose meaning is not readily apparent, please provide a translation in parentheses.

Use American, not British, spelling (honor, not honour; labor, not labour).

Carefully check accent marks in titles, names, etc.

LENGTH: Five thousand words is the maximum length for articles (including footnotes, charts, maps, graphs). This is about 20 pages double-spaced.

NOTES: Please use the footnoting function in MSWord, and remember to double-space notes. Follow *CMS* [15th ed.] chapter 16 or [16th ed.] chapter 14 as a guide for the format of notes (models are found in [15th ed.] chapter 17 or [16th ed.] chapter 15). Abbreviate information for second and subsequent references, usually including the last name of author and a shortened title. Do not use any **Latin references** (op. cit., loc. cit.) with the exception of "Ibid." and "et al." The following examples cover only the most basic situations, so we urge you to consult *CMS* for other cases. **Please note that submitting manuscripts with incorrectly formatted footnotes may result in a delay in a decision about including your article in the *Proceedings* or even rejection.**

**N.B.** It is not necessary to give urls for articles appearing in print publications.

**Archival sources:**

Notes of archival sources may vary in the *Proceedings*, but we require authors to be consistent in their own articles. Make sure that all of the following elements (as relevant) are present, that they are arranged logically, and that they are recognizable: name of archive and location with abbreviation in brackets for subsequent citation; fonds and/or shelfmark; other information identifying a particular document therein, e.g., title, if any; your description, if any; date; pages or folio numbers.

Please check—and double check—the spelling of all foreign language publications.

**TYPING: All text must be double-spaced**, even quotations and footnotes. Do not justify the right margin. Please prepare text in Microsoft Word. We have the ability to read either Macintosh or Windows versions of Word.

**GRAPHICS:** The *Proceedings* does publish graphics such as photographs, tables, and other figures. In the case of photographs, however, you must secure all permissions to publish and provide captions. In the case of figures that you yourself have generated, **please contact Joelle Neulander immediately about the best way to prepare your graphics for publication.** All photographs, figures, or other graphics should be submitted as separate files in .png or .jpg format at a resolution of 600 dpi. In a separate document, please provide captions as you want them to appear in the *Proceedings*, including permissions.
